Genuine Care Discounts

Multi-Policy Discount

A customer is eligible for a multi-policy discount when they combine two or more of their policies with NYCM Insurance. Bundling your insurance policies saves you both time and money when managing your auto, home, renters, and/or umbrella policies.

Homeownership Discount

If you own a house, mobile home, condominium, or co-op, whether NYCM Insurance holds your insurance policy for the property or not, you are eligible for a discount on your auto insurance premium.

Senior Discount

A discount will be applied to the policy of those over the age of 65 if they have been insured with NYCM Insurance and meet the qualifications of the Claim Free Discount.

Driver's Education Discounts

Accident Prevention Course/Defensive Driving Discount

Completing an approved accident prevention course and providing proof of completion will allow for a discount on your policy.

Driver Training Discount

Policies insuring drivers under the age of 21 may be eligible for a discount after satisfactory evidence is provided that the driver has completed a driver education course. Driver's Education Discounts Cont.

Good Student Discount

Vehicle owners or operators between 16 and 24 years of age who are full-time high school, college, or university students who hold a grade point average of a B or its equivalent, may qualify for discounts. Contact your agent for additional details about this discount program.

Student Away at School Discount

Parents who include coverage for their college students that are 24 years or younger may be eligible for a discount to their premium while their child is away at school without a vehicle, as long as they reside at least 100 miles away from where the car is kept. Contact your agent for more details and eligibility.

Commercial Driver License (CDL) Discount

A Commercial Driver License (CDL) discount is available to rated drivers that have a current/active CDL license designation. Drivers with a CDL license must also be claim free & violation free for the previous five years. A Motor Vehicle Report will be used to determine a rated driver's eligibility for this discount.


Payment Related Discounts

Paid in Full Discount

A Paid In Full Discount is given to policyholders who pay their 12 month premium in full on the policy effective date.

Auto-Pay (EFT) Discount

Policyholders who enroll in auto-pay (EFT) for payments will receive a discount.



Vehicle Equipment Discounts

Airbag/Automatic Seatbelts Discount

If your car has factory installed motorized safety belts and/or one or more airbags, you could qualify for a discount on your premium.

Alarm System (Anti-Theft) Discount

If your car has a built-in anti-theft system, you could be eligible for a discount on your policy.

Daytime Running Lights

Having daytime running lights as one of your car's features will provide you with a discount on portions of your premium.

New Car Discount

Just purchased a brand new car? Great news - vehicles produced for the current or upcoming model year qualify for a new car discount on collision coverage.

*This discount will only apply if the vehicle has not been previously titled.

Advanced Safety Features Vehicle Discount

Discount opportunity for customers who have vehicles with Advanced Safety Feature Discounts (forward collision warning, lane departure, back-up camera, etc.)
